Hospital and Outreach Education Alternative Provision Academy is committed to safeguarding and promoting the welfare of children and young people and expects all staff, volunteers and visitors to share this commitment.

Irrespective of your association with the academy, be it as a member of staff, volunteer or visitor, we request that whilst you are at Hospital and Outreach Education, you abide by our policies and procedures which are there to keep everybody safe.

Please ensure you wear your identification or visitors badge at all times whilst on the premises.

All our staff are appropriately trained and we have a staff code of conduct which is based on 'Guidance for safer working practice for those working with children and young people in education settings' (Safer Recruitment Consortium, February 2022).

If, at any time during your visit to HOE, you have any concerns about the conduct of a member of staff you encounter, you should report this to the Headteacher immediately. If your concern is about the Headteacher, please contact Chair of the Local Advisory Board, Sarah Hutt 07468 485268.

Reporting Incidents

All staff are responsible for investigating and reporting incidents of bullying, child on child abuse, homophobia, racism or any online safety concerns to a senior member of staff who is responsible for maintaining records and informing appropriate agencies.

During your visit if you encounter or are made aware of any incident, involving either bullying or racism, please speak to any member of staff.

First Aid Health and Support

In the event of you or a pupil needing first aid, please speak to any adult who can, if necessary, assist you.

Health and safety

Health and safety issues are monitored to ensure that the HOE provides a safe environment for all students, staff and visitors.

You have a responsibility to ensure that your actions do not put others at risk. Please ensure you follow instructions whilst on site and do not operate machinery or equipment that you are not trained to use. Please report anything you encounter which may pose a health and safety risk.

In the event of a fire, an alarm bell will sound. Please leave by the nearest exit which will be pointed out to you and muster in the area indicated by teaching staff.

Use of personal mobile phones and other electronic equipment, including laptops and tablets

You are not permitted to use your personal electronic equipment on HOE premises, which includes mobile phones. Please also switch off your 3G/4G/5G remote data. This is to protect the children and young people we work with. If you need to, for emergency purposes, please speak to a member of staff to discuss. If you cannot adhere to this requirement, you will be asked to leave the premises.

Child on child abuse

Child on child abuse is any abuse of a child or children that is perpetrated by another child or children. This includes all forms of sexual harassment, sexual violence and abuse. We strive to create a culture of safety, where children are free from harassment or abuse of any kind. We take a zero-tolerance approach to sexual violence and sexual harassment - it is never acceptable and it will not be tolerated.

We know that even if we do not receive any reports relating to child on child abuse, it does not mean that it is not happening. In fact we assume it is happening here. We support and encourage anyone - especially our pupils - to come forward to share any concerns about child on child abuse so that we can take action to keep all children safe.

- Signs of neglect, such as unsuitable clothing, poor hygiene, extremely pale or fatigued
- Anything else that makes you feel uncertain

How to respond if a student says they want to tell you something or begins to tell you:

- Tell them that you are not the right person to listen
- Ask them which member of staff they would like to talk to and take the child to that staff member
- Reassure them and tell them they have done the right thing
- Don't start to investigate the matter yourself
